An agreement by and between RIDGEWOOD KENNELS and _____ pertaining to the dog described above.
(hereinafter referred to as "OWNER")

THE TERMS OF THE AGREEMENT ARE THAT:

1. RIDGEWOOD KENNELS will take into possession the described dog for purposes of training for an unspecified period of time. RIDGEWOOD KENNELS will make a diligent effort to train the dog in the functions normally expected of a dog having an equal amount of training. However, no guarantee--expressed or implied—that the effort to train this dog will be successful, is part of this agreement.
2. OWNER will, prior to enrollment, affirm that the general health conditions of the dog are good, or specify abnormalities known by the owner. OWNER will also ensure **RABIES, PARVO, BORDATELLA** and **DHL** shots are current.
3. RIDGEWOOD KENNELS will provide adequate food, water and shelter to assure the physical welfare of the dog. The cost of food, other than that normally supplied by RIDGEWOOD KENNELS, specified by the owner or deemed necessary by RIDGEWOOD KENNELS will be borne by the OWNER.
4. RIDGEWOOD KENNELS will, in the event of sickness of, or calamity to the dog, secure the services of a veterinarian. All incurred medical expenses will be borne by the OWNER. There will be a **\$25 fee** per vet trip. The parties hereto agree that RIDGEWOOD KENNELS or their employees or their agents will not be held liable in the event of the loss of, or the demise of or the injury of this dog for any cause.
5. OWNER will pay **\$600.00 per month** for the period of time agreed upon. Failure to make payment by the **FIFTH** day after the due date will result in **the interruption of training** and a **\$50** late fee. This amount does not include entry fees and expenses as agreed upon. If payment is not received **in full** within 30 days of the due date, the pet will become the sole possession of RIDGEWOOD KENNELS and OWNER agrees to render any and all registration papers to RIDGEWOOD KENNELS. We reserve the right to sell the animal to redeem the cost of training and boarding. All fees will be paid **in full** before the dog leaves the premises.
6. Training fees and kennel space are PER MONTH and are not pro-rated.
